

IT'S TIME TO RE-ENROLL!



YOU PLAY A CRITICAL ROLE IN OUR PLANNING

The FACTS enrollment portal has been updated and will be open for re-enrollment on Saturday, January 27! We ask you to please complete your re-enrollment soon.

By re-enrolling early you will help us gain a clearer picture of the space we will have available in each classroom for NEW students. This helps us with staffing and creating a budget which accurately reflects where we will be in August, when our doors open for the 2024-25 school year.

RE-ENROLLMENT

Current families re-enroll by logging onto their current FACTS account and clicking the “Set up a Payment Plan” button in the “Financial Account” section of your FACTS portal. The process will be exactly the same as it has been in past years. Re-enrollment takes about 5 minutes and is complete once you approve payment of the Enrollment Fee.

Families with a NEW sibling starting

For all new siblings starting in the fall, in addition to enrolling them on FACTS, along with your other children, you will also need to complete a New Sibling Paper Application. Please submit this paper application, along with the child's original birth certificate, as soon as possible. If the sibling is an older student, we will need to have copies of report cards, standardized test results, and any IEP or 504 information which the student may have. The **New Sibling Application** can be found on the school website or in the school office.

FAMILY FINANCIAL INCENTIVES

\$100 OFF ENROLLMENT FEE THROUGH MARCH 4, 2024

We will once again offer 'HALF OFF' the Enrollment Fee from now through March 4th. Applications must be completed and the \$100 fee paid by 11:59 pm on March 4th to receive the discount. This will be programmed into the FACTS system so there will be no exceptions.

\$300 FAMILY REFERRAL CREDIT

Did you know that you can earn \$300 per family that you refer to PFGA? If someone who enrolls lists you as the family who referred them to our school, and if they stay at our school at least through Christmas of 2024, remaining in good standing, you will get a \$300 credit on your January 2025 FACTS bill for each new family referred! If you are listed along with any other PFGA families you will receive the proportionate amount of that \$300. There is NO LIMIT on this so feel free to bring in multiple families!

STUDENT INCENTIVES

PIZZA PARTY FOR THE FIRST CLASS AT 100%

The first classroom to get to 100% re-enrollment will receive a PIZZA PARTY and the teacher will receive an extra prep period!

OUT OF UNIFORM PASS FOR ENROLLING BY APRIL 1

Students who are fully enrolled on FACTS by April 1, 2024 qualify.

FINANCIAL ASSISTANCE

Re-enrolling your kids for next year and applying for financial assistance are two separate processes within the FACTS portal. If you plan to apply for financial assistance you will need to do **BOTH** the Re-Enrollment on FACTS (Set up a Payment Plan) and the FACTS Grant and Aid Application.

The FACTS Grant and Aid Application opens February 1st. All families who would like to be considered must apply each year, even for renewal of aid. Families should use their 2023 tax returns AND W-2s for this process.
